Amended and Restated 2009 Stock Incentive Plan; 60,280 shares subject to the attainment of a \$455.66 per-share hurdle; 60,280 shares subject to the attainment of a \$496.58 per-share hurdle; and 60,280 shares subject to the attainment of a \$564.04 per-share hurdle (each with a six-year term; and the merger exchange ratio of .9042 was applied to the number of shares and per share hurdles). One third of the Restricted Stock Units will be first eligible to vest on each of the third, fourth and fifth anniversaries of the date of grant subject to achievement of the applicable per-share price hurdles. Any Restricted Stock Units that have not vested within 6 years from the date of grant will be cancelled.
- Withholding of securities for the purpose of paying taxes.

- Shares held by the Rutledge GRAT B UA, dated August 13, 2018.
